<b>Preamble—</b>	1
Parliament’s reasons for enacting this Act are—	2
<b>1.</b> The Government of the Commonwealth proposes to introduce a Bill for a proposed law to alter the Constitution of the Commonwealth to establish the Commonwealth of Australia as a republic with a President chosen by a two-thirds majority of the members of the Commonwealth Parliament.	3 4 5 6 7
<b>2.</b> If passed by an absolute majority of each House of the Parliament, the proposed law will be put to the Australian people at a constitutional referendum in accordance with section 128 of the Constitution of the Commonwealth.	8 9 10 11
<b>3.</b> If the proposed law is approved by the Australian people, it is desirable that the <i>Australia Act 1986</i> of the Commonwealth and the <i>Australia Act 1986</i> of the Parliament of the United Kingdom be amended to remove any impediment to the alteration by a State of its laws relating to the powers and functions of Her Majesty and the Governor in respect of the State.	12 13 14 15 16
<b>4.</b> Section 15(1) of each of the Australia Acts mentioned in provision 3 of this preamble provides for the amendment of each of those Acts by an Act of the Parliament of the Commonwealth passed at the request or with the concurrence of the Parliaments of all the States and, subject to section 15(3) of each of those Acts, only in that manner.	17 18 19 20 21 22

Commonwealth and section 7 of the Australia Act 1986 of the  
Parliament of the United Kingdom**

**The Parliament of Australia enacts:**

**1 Short title**

This Act may be cited as the *Australia Acts Amendment Act 1999*.

**2 Commencement**

- (1) This Act commences on a day to be fixed by Proclamation.
- (2) That day must not be before the day on which the *Constitution Alteration (Establishment of Republic) 1999* receives the Royal Assent.

**3 Schedule(s)**

Each Act that is specified in a Schedule to this Act is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this Act has effect according to its terms.
